ASSIGNMENT OF PATENT APPLICATION

Whereas, Robert Moore Title Ten Manufacturing has a pending patent application, Serial No. 16/180,059, which claims priority from U.S. Patent Application No. 15/446,068, which claims the benefit of U.S. Provisional Application 62/301,794; and

Whereas, Robert Moore thereafter assigned the entire right, title and interest therein to the undersigned, Title Ten Manufacturing ("Title Ten"); and

Whereas, Newco Title Ten, LLC ("Newco"), having a place of business at P.O. Box 2487, 401 W. Willard, Muncie, Indiana 47307, entered into an Asset Purchase Agreement with Title Ten which included the right for Newco to acquire the entire right, title and interest in and to said invention and in and to any Letters Patent that may be granted therefore in the United States and its territorial possessions and in any and all foreign countries;

Now, therefore, for good and sufficient consideration, the receipt and sufficiency of which is hereby acknowledged, Title Ten by these presents does sell, assign and transfer unto Newco, the full and exclusive right to the said invention in the United States and its territorial possessions and in all foreign countries (including the right to claim priority under the terms of the International Convention and other relevant International Treaties and Arrangements from the aforesaid application) and the entire right, title and interest in and to any and all Letters Patent which may be granted therefor in the United States and its territorial possessions and in any and all foreign countries and in and to any and all divisions, reissues, continuations, substitutions and renewals thereof.

Title Ten hereby authorizes and requests the Patent Office Officials in the United States and its territorial possessions and any and all foreign countries to issue any and all of said Letters Patent, when granted, to said Newco as the assignee of Title Ten's entire right, title and interest in and to the same, for the sole use and benefit of Newco, its successors and assigns, to the full end of the term for which said Letters Patent may be granted, as fully and entirely as the same would have been held by Title Ten had this Assignment not been made.


