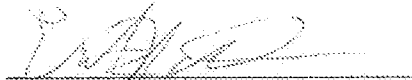
ASSIGNORS hereby agree to execute any papers, provide and information and testify in any interference or litigation at the request of ASSIGNEE, its successors, assigns and legal

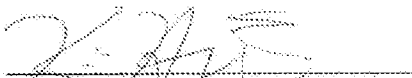
