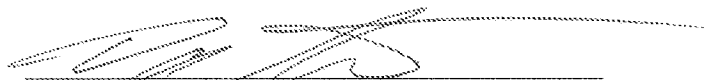
WEHREAS, ASSIGNOR believes himself to be the original inventor or a joint inventor of subject matter described in each of the Patent Applications;
