3. Assignor hereby authorizes and requests the corresponding Patent Offices to issue letters patents based on the Patents to the Assignee for the sole use and enjoyment of the Assignee, its successors and assigns.

4. Assignor hereby transfers to Assignee all rights to sue or recover and retain damages or account of profits and costs and attorney fees for past, present and future infringement or misappropriation of the Patents.


