RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE OF SECURITY INTEREST IN PATENTS is dated as of June 4, 2019, by HUNTINGTON NATIONAL BANK (as successor by merger to FirstMerit Bank, N.A.), in its capacity as Lender (the "Grantee"). WHEREAS, under the Security Documents, the Grantor granted the Grantee a security interest in, among other things, certain Patents (as defined in the Patent Agreement), including, without limitation, the Patents listed on Schedule I attached hereto, and the goodwill of the businesses with which the Patents are associated, as security for certain obligations of the Grantor to the Grantee;

WHEREAS, the Grantee recorded the Patent Agreement on February 10, 2015, at Reel 0034944, Frame 0181 with the United States Patent and Trademark Office; and

WHEREAS, the Grantor has requested that the Grantee release its security interests in the Patents listed on Schedule I hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby fully discharges, releases and terminates its security interests in and liens on the Patents listed on Schedule I hereto, and the goodwill of the businesses with which the Patents are associated, and any right, title or interest of the Grantee in the foregoing under the Security Documents shall hereby cease and become void.
