THIS IS THE LAST WILL AND TESTAMENT of me WANG KENNETH KUK KEI (王克繼) Merchant of House 6, Green Villa, DD223 Lot 251, 7.5M Clearwater Bay Road, Sai Kung, Hong Kong which I make on this [ 5<sup>th</sup> ] day of June Two Thousand And Nine.

1. I APPOINT my wife, WANG QUEK SWEE LING, LINDA (王郭瑞琳), also of House 6, Green Villa, DD223 Lot 251, 7.5M Clearwater Bay Road, Sai Kung, Hong Kong to be the sole executrix and trustee of this my Will but if she is unable or unwilling to act or she shall die in my lifetime or after my death without having proved it, then I APPOINT my daughter, WANG JANICE JAN YEE (王靜怡), and my son, WANG JASON LAP TAU (王立濤), both of House 6, Green Villa, DD223 Lot 251, 7.5M Clearwater Bay Road, Sai Kung, Hong Kong to be the executors and trustees hereof.
2. In this my Will the expression "my trustees" shall mean the trustee or trustees specifically appointed hereunder and shall include the trustees for the time being hereof.
3. If my wife, the said WANG QUEK SWEE LING, LINDA (王郭瑞琳), shall survive me for more than 30 days, I GIVE BEQUEATH and DEVISE to her absolutely all my real and personal property whatsoever and wheresoever.
4. If my wife, the said WANG QUEK SWEE LING, LINDA (王郭瑞琳), shall fail to survive me for the said period of 30 days, then the provisions in Clause 3 above shall not have effect and, in lieu thereof, the provisions in clauses 5 to 11 herebelow inclusive

shall have effect.


5. I give all my real and personal property whatsoever and wheresoever to my trustees upon trust to sell call in and convert the same into money, with power to postpone such sale, calling in and conversion for so long as they shall in their absolute discretion think fit without being liable for loss.
6. My trustees shall, out of the monies to arise from the sale, calling in and conversion of or forming part of my estate, pay my debts funeral and testamentary expenses and legacies and all estate duty payable in respect of my estate and shall invest the residue of such monies in any investments of a nature hereby authorized, with power from time to time to vary investments for others of an authorized nature, and shall stand possessed of such investments and of all parts of my estate for the time being remaining unsold and any ready money (hereinafter called my residuary estate) upon the trusts hereinafter declared concerning the same.
7. My executors and trustees shall distribute my residuary estate equally to all my 5 children, namely, WANG JANICE JAN YEE (王靜怡), WANG JASON LAP TAU (王立濤), WANG JONATHAN JULIAN LAP FUN (王立勳), WANG JEFFREY LAP HAN (王立漢) and WANG JEREMY LAP YUEN (王立源).
8. If any child of mine shall die in my lifetime or after my death but before attaining a vested interest leaving a spouse and issue(s), such spouse and issue(s) shall take by substitution the share of my residuary estate which such deceased child of mine would have taken if he or she had survived me and attained a vested interest in the proportions



be entitled to charge and be paid all usual professional or other charges for business done services rendered or time spent by him or his firm in the administration of my estate or the trusts hereof, including acts which a trustee not engaged in any profession or business could have done personally.
