Assignor further agrees, without any payment by said Assignee other than expenses incurred by the undersigned, to communicate to said Assignee, its representatives or agents, any facts relating to said invention, including evidence for interference purposes or for other proceedings, whenever requested; testify in any interference, litigation or other proceedings, whenever requested; and to execute

and deliver, on request, all lawful papers required to make any of the foregoing provisions effective, and likewise make these provisions binding upon Assignor's successors, administrators and assigns.


