- d. together with the right to recover all damages, including, but not limited to, a reasonable royalty, by reason of any past, present, or future infringement or any other violation of patent or patent application rights; and
- e. to have and to hold for the sole and exclusive use and benefit of the Assignee, its successors and assigns, to the full end of the term or terms for all such patents.

The Assignors hereby covenant and agree, for both the Assignors and the Assignors' legal representatives, that the Assignors will:

- a. assist the Assignee in the prosecution of the patent applications identified above;
- b. assist the Assignee in the making and prosecution of any and all other patent applications that the Assignee may elect to make covering the inventions identified above;
- c. assist the Assignee in vesting in the Assignee like exclusive title in and to all such other patent applications and patents; and
- d. execute and deliver to the Assignee any and all additional papers which may be requested by the Assignee to carry out the terms of this Assignment.

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment. This Assignment may be executed in any number of counterparts, each of which shall be an original and all of which, taken together, shall constitute a single Assignment. All of the terms, conditions and covenants of this Assignment shall be binding upon and shall inure to the benefit of the heirs, personal representatives, successors and assigns of the parties hereto.

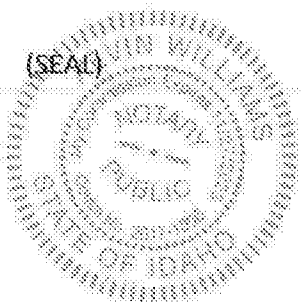
