DEED OF CONFIRMATION

- 2. This Deed is governed by the laws of Victoria, Australia and the parties submit to the non-exclusive jurisdiction of the courts of that State.

3. This Deed may be signed in multiple copies, all of which shall constitute a single Deed and each of which shall be deemed to be an original.


