AND WHEREAS IP Holdings has prior to this Agreement, extinguished, terminated and further released the inventors from any and all of the obligations of cooperation of the inventors for the Assigned Properties as further described in a Release and Termination of Non-Ownership Rights between IP Holdings and the inventors, for which said Release is binding on all successors and future assigns of the Assigned Properties;

NOW THEREFORE, for value received by the IP Holdings, the sufficiency of which is acknowledged by the Parties, IP Holdings hereby assigns all ownership rights in and to the Assigned Properties to Airspace Reality, and to legal successors and assigns of Airspace Reality;

AND the Assigned Properties shall include only the properties identified as the Assigned Properties;

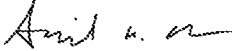

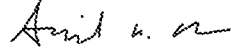
