## PATENT ASSIGNMENT

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00), the receipt whereof is hereby acknowledged, and for other good and valuable consideration, Assignor hereby sells, assigns and transfers unto the Assignee, its successors and assigns, the entire right, title and interest, including the right to sue for past infringement, if any, and the right to claim priority, in and to said application, the inventions therein disclosed, and any improvements thereon, and in and to any and all Letters Patent which may be granted therefor in the United States and its territorial possession, in any and all foreign countries, including without limit all PCT Contracting States, and in and to any and all non-provisional applications claiming priority thereto and any and all divisions, continuations, substitutions, renewals, re-examination, extension and reissues thereof, and any other applications claiming priority thereto;

Assignor hereby does authorize and request the Patent Office Officials in the United States and its territorial possessions, and in any and all foreign countries, to issue, when granted, any and all Letters Patents thereon, and reissues thereof, to the Assignee as the assignee of the entire right, title and interest in and to the same, for the sole use and behalf of the Assignee and the Assignee's successors and assigns, to the full end of the term for which said Letters Patents may be granted, as fully and entirely as the same would have been held by Assignor had this assignment and sale not been made; and

Assignor hereby authorizes the Assignee, its successors and assigns, to file in its own name applications for patent in foreign countries in connection with the inventions hereby transferred, under the International Convention claiming the priority of said United States application or otherwise, and to secure in its own name the patent or patents issued thereon; and

Assignor hereby agrees that, upon request, Assignor will sign all papers, and make all rightful oaths, and do all acts which the Assignee, its successors or assigns, may consider necessary in connection with said United States application, and in connection with any other United States or foreign applications that may be filed in connection with said inventions, and with any improvements thereon, and in connection with any patents issued or reissued thereon.

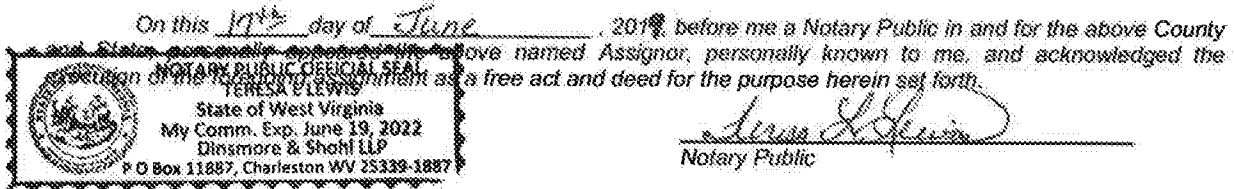
