ASSIGNMENT

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee (i) all of Assignor’s right, title and interest in and to the Inventions, all improvements therein, the Applications and all priority rights arising therefrom, and any applications and/or patents, and any reissues and extensions thereof, which issue in any country upon any patent applications which correspond with any of the following: the Patents, the Applications; any application that claims priority from the Applications or Patents (including utility applications, divisionals, continuations, continuations-in-part, international applications and/or any foreign regional and/or national applications), or any application based in whole or in part on any of the foregoing.

Assignor agrees that Assignor and Assignor’s heirs and legal representatives will, without further consideration, (a) cooperate with Assignee in the maintenance, protection, and prosecution of the Patent Rights, and maintenance, protection, and prosecution of foreign counterparts; (b) execute, verify, acknowledge and deliver all such further papers, including patent applications and instruments of transfer; and (c) perform such other acts as Assignee lawfully may request to obtain or maintain the Patent Rights.

Assignment

The terms and covenants of this agreement shall inure to the benefit of Assignee, its successors, assigns and other legal representatives, and shall be binding upon Assignor, and Assignor's respective heirs, legal representatives and assigns.

All of the rights, title and interest in and to the Patent Rights transferred, assigned and set over to Assignee hereunder include all income, royalties, damages and payments now or hereafter due or payable with respect thereto, and all causes of action (whether in law or equity) and the right to sue, counterclaim, and recover for the past, present, and future infringement of the Patent Rights assigned or to be assigned hereunder.

Assignor grants the attorneys of Baker, Donelson, Bearman, Caldwell & Berkowitz P.C. associated with Customer Number 127015 the power to insert in this Assignment any further identification or information which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office (or any foreign patent office) for recordation of this document.

Assignor hereby warrants and represents that it has not granted and will not grant any licenses or other contingent or non-contingent right, title, or interest under or relating to the Patent Rights, or is, was, or will be under any obligation, that does or will conflict with or otherwise affect this Assignment, including any of Assignor's representations, warranties, or obligations or Assignee's rights hereunder.

Assignor hereby warrants and represents that Assignor has not entered and will not enter into any assignment, contract, or understanding in conflict herewith.

This Assignment may be executed in any number of duplicate originals and each duplicate original shall be deemed to be an original. This Assignment may be executed in several counterparts, each of which counterparts shall be deemed an original instrument and all of which together shall constitute a single Assignment. The failure of any party hereto to execute this Assignment, or any counterpart hereof, shall not relieve the other signatories from their obligations hereunder.


