ASSIGNMENT OF PATENT APPLICATION

therefor, and together with the right to file said patent application or any non-provisional, divisional, continuation, or continuation-in-part thereof in the United States, or in any foreign country or jurisdiction under the Paris Convention or the Patent Cooperation Treaty, such interests, claims, and rights to be held and enjoyed by the Assignee for its own use and for its successors and assigns, to the full end of the term for which a patent issuing from said patent application may be granted, and any reissues, reexaminations, renewals, or extensions thereof as may be granted, as fully and entirely as the same would have been held by the named Inventor had this Assignment not been made;


