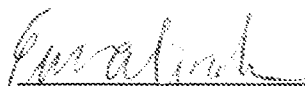
AND we request that any and all Letters Patent for said invention be issued to said assignee, its successors, assigns and legal representatives, or to such nominees as it may designate.
