ASSIGNMENT OF PATENTS

This ASSIGNMENT OF PATENTS (this "Assignment") is made, executed and delivered as of January 7, 2019 by and between Halliburton Energy Services, Inc., a Delaware corporation, ("Assignor"), and Davidson Instruments, Inc. a Delaware corporation ("Assignee").

WHEREAS, Assignor owns certain rights in United States Patent Nos. US 8,115,937; US 8,049,898; and US 7,305,158 ("Assigned Patents") and desires to assign any and all interest it has or may have therein to Assignee;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties hereto, the Assignor and Assignee hereby agree as follows:

1. The Assignor hereby sells, assigns and transfers unto the Assignee its successors and assigns, any and all of the Assignor's right, title, interest, property and benefit in and to the Assigned Patents, the inventions described or claimed therein, and any and all continuations, continuations-in-part, divisions, renewals and substitutes for said Assigned Patents, and under any and all patents which may be granted under reissues or extensions or re-examinations of such Assigned Patents, the same to be held and enjoyed by the Assignee, for its own use and behoove, and for its legal representatives, successors and assigns, to the full end of the term for which any patent may be granted, as fully and entirely as the same could have been held and enjoyed by the Assignor if this Assignment not been made.

2. The Assignor hereby agrees to undertake, upon reasonable request, to sign all papers, make all rightful oaths and do all requisite acts for the filing of any disclaimer or for the filing and assignment of any reissue application or applications for patent based on the Assigned Patents.

3. The Assignor hereby agrees to undertake, upon reasonable request, to sign such documents and do such things as may be required to give effective legal and registered title to the Assignee to the Assigned Patents, all without further consideration but at the sole expense of the said Assignee.

4. This Assignment and the legal relations between the parties hereto shall be governed by and construed in accordance with the Laws of the State of Texas without regard to any principles of conflicts of Laws that would result in the application of the Laws of any other jurisdiction. Each party hereto (a) hereby irrevocably consents to submit itself to the personal jurisdiction of any state or federal court located in Houston, Texas and the United States District Court for the Southern District of Texas in the event of any dispute that is settled by litigation, and (b) covenants not to attempt to deny or defeat such personal jurisdiction by motion or other request for leave from any such court.

5. This Assignment may be executed in one or more counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument. A facsimile transmission or an email in portable document format of a signed copy of this Assignment will be deemed an original and will have the same valid and binding effect thereof. Minor variations in the form of the signature page, including footers from earlier versions of this Agreement or any such other document, will be disregarded in determining the party's intent or the effectiveness of such signature.
