If ASSIGNORS are requested by the owner of the rights conveyed hereby to take action under this paragraph the owner shall reimburse ASSIGNORS for reasonable out-of-pocket expenses actually paid by ASSIGNORS and incurred and paid as a result of complying with the owner's request; provided that receipts showing the amount actually paid are submitted to such owner.




