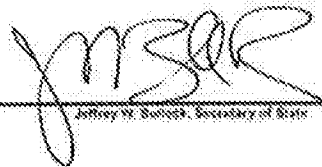

RESOLVED that the Certificate of Formation of Linde LLC is amended by changing the first article so that, as amended, it reads as follows:

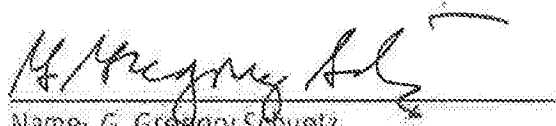
Name: The Name of the Company is Messer LLC.
