1. A partial asset contribution from SOCIETE NATIONALE D'ETUDE ET DE CONSTRUCTION DE MOTEURS D'AVIATION, with the company number RCS 8562 11 997, to LEXVALL, which company number is RCS 414 815 217, effective on 29 October 2009.
2. A change of name from LEXVALL to SNECMA MOTEURS, effective on 3 January 2000.
3. A change of name from SNECMA MOTEURS to SNECMA, effective on 12 May 2005.
4. A merger between SNECMA, 2 Boulevard du Général Martial Valin, 75015 Paris, France, with Company Number R.C.S. PARIS 414 815 217, and SNECMA SERVICES SA, abbreviated SNECMA SERVICES, with Company Number R.C.S. PARIS 562 056 408. These entities merged under the name SNECMA, with Company Number R.C.S. PARIS 414 815 217, the merger being effective on 11 March 2009.
5. A change of name from SNECMA to Safran Aircraft Engines, effective on 3 August 2016.

In addition, I hereby declare that SNECMA Société Anonyme, SNECMA SAS and SNECMA are associated with the same Company Number, R.C.S. PARIS 414815217, and thus they are the same legal entity.

I have executed this instrument as a lawful representative of the company with authorization to execute certain documents relating to patents, utility models, designs and trademarks on behalf of the company.


