or legal representatives; (ii) communicate to Assignee or to its nominee all known facts; (iii) testify in any administrative or legal proceedings, including any interference, arbitration, opposition, reexamination, inter partes review, post grant review, or litigation; (iv) execute and deliver all lawful papers and documents, including all petitions, specifications, affidavits, declarations, and disclaimers; (v) furnish Assignee with any and all documents, photographs, models, samples, and other physical exhibits in my/our control or in the control of my/our heirs, legal representatives, or assigns, and (vi) make all rightful oaths, and generally to do everything possible to aid Assignee, its successors, assigns, and legal representatives to obtain, maintain, and enforce for its or their own benefit proper patent protection for said Invention or any part of it in any and all countries.
