TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT (this "Termination"), is dated as of June 4, 2019, and made by OAG Aviation Worldwide Limited, a limited liability company incorporated under the laws of England and Wales and OAG Aviation Worldwide LLC, a Delaware limited liability company (collectively, jointly and severally, ("Grantors")), to U.S. Bank Trustees Limited, in its capacity as security agent for the benefit of the Beneficiaries as secured party (in such capacity and together with any successors in such capacity, the "Security Agent").

WHEREAS, pursuant to that certain Patent Security Agreement dated May 12, 2017, made by Grantors to Security Agent (the "Patent Security Agreement"), a security interest was granted by the Grantors to Security Agent in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Patent Security Agreement was recorded with the patent division of the United States Patent and Trademark Office on May 12, 2017 at Reel/Frame 042364/0643; Reel/Frame 042364/0135; and Reel/Frame 042364/0236;

WHEREAS Security Agent now desires to terminate the Patent Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Security Agent hereby states as follows:

1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Intellectual Property listed on Exhibit A hereto.
2. Release of Security Interest. Security Agent terminates the Patent Security Agreement and terminates, releases and discharges without representation, warranty or recourse its security interest in the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Security Agent in the Intellectual Property.


