

AND We HEREBY further assign and transfer to LiveClips LLC all priority rights derived from such application therefore by virtue of the International Convention for the Protection of Industrial Property for any and all member countries of the aforesaid International convention and We do hereby assign and transfer to LiveClips LLC the sole right to file further applications for patents under the patent laws of any country of the world based on any improvements disclosed in said application as fully and entirely as the same would have been held by us had this assignment not been made.
