on the other hand.

Whereas:

- The Assignor is the rightful owner of the IP Rights, particulars of which are set out in the schedule attached hereto (hereinafter collectively called "the IP Rights") together with the goodwill that had accrued.
- The Assignee accepts all the rights, privileges and obligations as pertaining in the Assignment.
- In the framework of the present agreement, the Assignor and the Assignees agree that the IP Rights are sold, assigned, transferred and conveyed from the Assignor to the Assignees.
- The Assignor and the Assignee agree that this assignment be duly recorded before the relevant intellectual and/or Industrial Property Office as required to protect the acquired rights and obligations, and by the Assignee alone where the laws of the jurisdiction before which the present assignment is to be recorded allow so.

Now this deed witnesseth as follows:

- In consideration of One Euro and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby sells, assigns, transfers and conveys to the Assignee all its rights, including any right to claim priority to any of the IP Rights, title, interest and obligations in the IP Rights, including any provisional, divisional, substitute, continuation, continuation-in-part, reexamination and reissue applications, reissue IP Rights issued on such reissue applications, extensions, any foreign applications, including international and regional applications, based in whole or in part on any the IP Rights, together with all the rights, powers, privileges and immunities arising or accrued therefrom, including the right to take such proceedings as may be necessary to recover damages or otherwise in respect of infringements committed before as well as after the date hereof and including the goodwill of the business associated with the said IP Rights, but subject to all rights, licenses and other encumbrances already existing in respect thereof.
- The Assignor hereby covenants with the Assignee that the Assignor will, at the expense of the Assignee, execute, sign and do all such instruments, applications, documents, acts and things as may reasonably be required by the Assignee to enable the Assignee (or the nominee of the Assignee) to enjoy the full benefit of the property and rights hereby assigned.
- The Assignee hereby accepts this assignment with all the rights, privileges and obligations as pertaining thereto.
- The person signing this document on behalf of the Assignor expressly declares to be duly empowered to execute documents on behalf of the Assignor and alienate assets of the Assignor.
- The person signing this document on behalf of the Assignee expressly declares to be duly empowered to represent the Assignee.
- Should the laws of the jurisdiction before which the present assignment is to be recorded allow so, this Assignment may be executed in counterparts, each of which will be an original as regards any party whose signature appears thereon and all of which together will constitute one and the same instrument.
