- 2 The Assignor HEREBY COVENANTS that it will at the expense of the Assignee execute, sign and do all such instruments, applications, documents, acts and things as may reasonably be required by the Assignee to enable the Assignee, the nominees of the Assignee, their successors or assigns to enjoy the full benefit of the property and rights hereby assigned and to enjoy the exclusive benefit of any extension, prolongation or further grant of patents for the time being vested in the Assignee by virtue of this Assignment.
- 3 This Assignment will be governed by and interpreted in accordance with the laws of England & Wales.
