**JURONG SHIPYARD PTE. LTD.** (hereinafter "Assignee"), a company incorporated under the laws of Singapore, having a place of business at 29 Tanjong Kling Road, Singapore 628054.

Whereas the Assignor and Assignee have entered into the Business and Asset Purchase Agreement dated August 8<sup>th</sup>, 2014 and executed the General Conveyance dated September 10, 2014 whereby the Assignor has assigned to the Assignee all intellectual property owned by the Assignee existing on the dates thereof or thereafter created (collectively the "IP Assignment");

And Whereas the Assignee is continuing to complete the process of registering the IP Assignment in various jurisdictions throughout the world such the Assignee will reflected as the registered owner of the intellectual property in such national and international registries, but the registration of the IP Assignment will take a period to time to complete;

And Whereas the Assignor and the Assignee agree that it is in the best interests of the parties that various improvement, modifications and extensions to the transferred intellectual property continue to be filed with the appropriate authorities on a timely basis to preserve the time priority of such claims;

And Whereas the various national and international intellectual property registries will not accept any filings on improvements, modifications and extensions to the transferred intellectual property in the name of the Assignee until the IP Assignment has been formally recorded in their respective jurisdictions;



NOW THEREFORE in consideration of the mutual covenants contained herein, and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. The Assignor hereby confirms the sale, bargain, conveyance, assignment, transfer, and setting over to the Assignee all of its right, title, interest, claim, and demand in and to all the inventions (the "Inventions") disclosed and claimed in any and all of the patents and patent applications owned by the Assignee or filed by the Assignee or in the name of the Assignee up to the effective date of the IP Assignment, between the date of the IP Assignment and the date hereof, and/or subsequent to the date hereof (collectively, the "Patents") , including, without limitation, any and all:
  - a) rights relating thereto that may arise at law, including rights of action resulting from prior infringement or other unauthorized use thereof;
  - b) applications corresponding thereto, whether in the form of improvements, divisions, continuations, continuations-in-part, re-examinations, re-issues and extensions thereof;
  - c) Letters Patent and like industrial property registrations (the "Registrations") that may issue, be granted or result from the Patents and the corresponding applications for the Inventions; and
  - d) rights of priority (including the right to claim the benefit thereof) resulting from the filing of the Patents, the corresponding applications and any previously filed applications in respect of the Inventions under international conventions, treaties or otherwise,

the same to be held and enjoyed as fully and exclusively as the same would have been held and enjoyed by the Assignor had the sale, bargain, conveyance, assignment, transfer, and setting over referenced above not been made.

2. For the sake of further clarity, the Assignor and Assignee hereby expressly confirm and acknowledge the agreement in the IP Assignment that any and all modifications, extensions or improvements to the Inventions and Patents after the date hereof belong solely to the Assignee.

The Parties further agree that any registrations relating to modifications, extensions or improvements to the Inventions and Patents required to be filed in the name of the Assignor subsequent to the date hereof as a result of the processing time required to record the assignments of the Inventions and Patents shall not in any way impact the ownership of such Inventions and Patents by the Assignee, and the Assignor shall be deemed to have filed such registrations as bare trustee of the Assignee pending completion of the recordation of the assignment.
4. The Assignor, on behalf of itself and its assigns, heirs or other legal representatives, does hereby covenant and agree to do all such lawful acts and things, and to execute and deliver without further consideration such further lawful assignments, instruments, assurances, applications and other documents, as may reasonably be required by the Assignee, or by its successors, assigns, nominees or other legal representatives, to obtain the Letters Patent and Registrations and vest or secure the same in the Assignee, and in Assignee's successors, assigns, nominees or other legal representatives.
5. The Assignor does hereby authorize any official whose duty it is to grant patents or industrial property registrations, to grant the Letters Patent and Registrations to the Assignee, and to the Assignee's successors, assigns, nominees or other legal representatives.
6. The Assignor, on behalf of itself and its assigns, heirs or other legal representatives, does hereby authorize the Assignee, its successors, assigns, nominees or other legal representatives to amend the present confirmatory assignment to insert or correct any identifying information of the Patents as may be necessary or desirable in order to comply with the rules of any Patent Office, including the United States Patent and Trademark Office, for the recordation of this document.



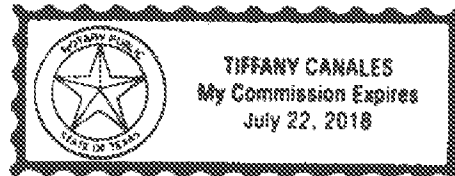
