PATENT SECURITY AGREEMENT

This PATENT SECURITY AGREEMENT ("Patent Security Agreement"), dated as of July 12, 2019, by and between DECERNIS LLC, a Delaware limited liability company ("Grantor"), in favor of GOLUB CAPITAL LLC, in its capacity as administrative agent for certain secured parties ("Administrative Agent").

WITNESSETH:

WHEREAS, pursuant to that certain Credit Agreement dated as of November 16, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among Global ID Group, Inc., Global ID Corporation, f/k/a P&P Food Safety US Acquisition, Inc., a Delaware corporation (collectively, the "Borrowers"), the other Loan Parties party thereto from time to time, Administrative Agent, and the Persons signatory thereto from time to time as Lenders, the Lenders have agreed to make Loans, from time to time, to the Borrowers;

WHEREAS, as a condition subsequent to making of Loans by the Lenders under the Credit Agreement, Grantor has executed and delivered to the Administrative Agent that certain Joinder to Security Agreement dated as of the date hereof (the "Joinder"), pursuant to which Grantor has become party to that certain Security Agreement dated as of November 16, 2016 by and among Grantor, the other Loan Parties party thereto from time to time and Administrative Agent (as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement");

WHEREAS, under the terms of the Joinder and the Security Agreement, the Grantor has granted to Administrative Agent, for the benefit of the Secured Parties, a security interest in certain Intellectual Property of the Grantor, and has agreed to execute and deliver this Patent Security Agreement, for recording with government authorities, including but not limited to, the United States Patent and Trademark Office with respect to all Patents of Grantor, whether now owned or existing or hereafter acquired or arising; and

WHEREAS, pursuant to the Joinder and the Security Agreement, Grantor is required to execute and deliver to Administrative Agent, for the benefit of Secured Parties, this Patent Security Agreement.

NOW, THEREFORE, in consideration of the premises and the mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby agrees as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement.

2. GRANT OF SECURITY INTEREST IN THE PATENT COLLATERAL. Grantor hereby grants to Administrative Agent, for the benefit of the Secured Parties, a continuing first-priority security interest in, and lien upon, all of Grantor's presently existing or hereafter acquired right, title and interest in and to the Patents, including, without limitation, the Patents set forth on Schedule A hereto, and all extensions, renewals and proceeds thereof (collectively, the "Patent Collateral").

3. SECURITY AGREEMENT. The security interests granted pursuant to this Patent Security Agreement are granted in conjunction with, and not in limitation of, the security interests granted to Administrative Agent pursuant to the Joinder and the Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of Administrative Agent with respect to the security interest in the Patent Collateral made and granted hereby are more fully set forth in the Joinder and the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

4. EXECUTION IN COUNTERPARTS. This Patent Security Agreement may be executed in any number of counterparts, each of which when so executed and delivered shall constitute an original, but all of which shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Patent Security Agreement by telecopy or other electronic imaging means shall be effective as delivery of a manually executed counterpart of this Patent Security Agreement.

5. GOVERNING LAW. THIS PATENT SECURITY AGREEMENT SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE INTERNAL LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAWS PRINCIPLES.
