RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this "Release") is given as of this 11 day of JULY, 2019 by Comerica Bank ("Secured Party") to DIRTT Environmental Solutions Ltd., Ice Edge Business Solutions Ltd., and DIRTT Environmental Solutions, Inc. (collectively the "Companies").

BACKGROUND

A. Companies and Secured Party entered into several transactions (collectively, the "Obligations"), pursuant to which Companies granted to Secured Party a security interest in the Companies' intellectual property assets, including the Companies' U.S. and Canada patents, registered trademarks, and copyrights (collectively, the "IP Assets"). The grant of security interest against the IP Assets have been recorded with, among others, the United States Patent and Trademark Office.

B. Companies satisfied all of the Obligations on 11 JULY, 2019, and therefore the security interest in the IP Assets have been fully satisfied and discharged, and the parties wish to evidence the release of the security interest in the IP Assets.

RELEASE

In consideration of the satisfaction and discharge in full of the Obligations, Secured Party has, and by this Release does, (1) terminate its security interest in the IP Assets of the Companies and fully releases and discharges all liens, security interests, right, title and interest it may have in and to the IP Assets; and (2) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Secured Party's rights to the IP Assets. Companies are hereby authorized to file this Release and any other instruments with the United States Patent and Trademark Office and any other office or agency to evidence the same, and to remove the recordation of Secured Party's security interest in the IP Assets.
