ASSIGNMENT

WHEREAS, I, Herve A. Fevrier, have invented certain new and useful improvements in "SYSTEM AND METHOD OF OPTICAL FIBER COMMUNICATION" disclosed in applications for Letters Patent, one of the applications filed as U.S. Patent Application No. 15/983,316 on May 18, 2018, another of the applications filed as International Patent Application No. PCT/GB2016/053613 on November 21, 2016, and another of the applications filed as U.S. Provisional Patent Application No. 62/258,360 on November 20, 2015;

I also hereby sell and assign to the ASSIGNEE, its successors, assigns and legal representatives, the full and exclusive right, title and interest to the invention disclosed in the applications throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for the invention in its own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of the invention and all rights to register the invention in appropriate registries; and I further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

I hereby further agree that I will communicate to the ASSIGNEE, its successors, assigns and legal representatives, any facts known to me respecting any improvements; and, at the expense of the ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in the ASSIGNEE and to aid the ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for the invention in all countries.
