- 4.2 Amendments and supplements to this agreement must be in writing and executed by all parties.

- 4.3 A term or part of a term of this agreement that is illegal or unenforceable may be severed from this agreement and the remaining terms or parts of the term of this agreement continue in force.
- 4.4 This agreement may be executed in counterparts. All executed counterparts constitute one document.
- 4.5 The Assignor acknowledges and agrees that the Assignee may assign, license or transfer any and all of its right, title and interest under this agreement.
- 4.6 This agreement is governed by the laws of Western Australia and each party irrevocably submits to the non-exclusive jurisdiction of the courts of Western Australia.
