**TERMINATION AND RELEASE OF
NOTICE OF GRANT OF SECURITY INTEREST IN PATENTS**

This Termination and Release of Notice of Grant of Security Interest in Patents (this "Termination"), dated as of July 23, 2019, is executed by Veery Brice Maxwell, as Collateral Agent (the "Collateral Agent"), in favor of Growing Energy Labs, Inc. (the "Company").

RECITALS

A. Pursuant to that certain Notice of Grant of Security Interest in Patents, dated as of November 7, 2017 (the "Patent Security Agreement"), by and between the Company and the Collateral Agent, the Company granted to Collateral Agent a security interest in the Patent Collateral (defined below).

C. Collateral Agent agrees to execute this Termination in order to evidence the termination and release of its security interest in the Patent Collateral (as defined below).

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent hereby agrees as follows:

(a) Collateral Agent hereby expressly terminates and releases all of Collateral Agent's right, title and interest in, to and under the patents and patent applications shown on Schedule 1 attached hereto (collectively, the "Patent Collateral").

(b) Collateral Agent represents and warrants that it has the full power and authority to execute this Termination.

(c) Collateral Agent authorizes and requests the Patent Division of the United States Patent and Trademark Office to record this Termination.

(d) From time to time after the date hereof, upon the Company's reasonable request, or upon the reasonable request of the Company's successors, assigns or other legal representatives, Collateral Agent agrees to provide the Company or their successors, assigns or other legal representatives with any information and additional authorization and documentation necessary to more fully and effectively effect the release of Collateral Agent's security interest in the Patent Collateral.
