## ASSIGNMENT FOR APPLICATION FOR PATENT

and (f) for legal proceedings involving said inventions and any application therefore and any Patents granted thereon, including without limitation opposition proceedings, cancellation proceedings, priority contests, public use proceedings, infringement actions and court actions; provided, however, that the reasonable travel, business and legal expenses incurred by Assignor in providing such cooperation shall be paid by Assignee.
