Confirmatory Assignment of Patents

This Assignment, made by and between Pfizer Italia S.r.l. a company organized under the laws of Italy having its registered office at Via Isonzo 71, 04100, Latina, Italy and administrative offices at Via Valbondione 113, 00188 Rome, Italy (*"Assignor"*), and

Pfizer Consumer Healthcare Italy S.r.l., a company organized under the laws of Italy, having its registered office at Via Isonzo 71, 04100, Latina, Italy and administrative offices at Via Valbondione 113, 00188 Rome, Italy (*"Assignee"*) (and collectively, *"the Parties"* or *"Party"*).

WHEREAS, Assignor and Assignee are parties to a certain Assignment dated 26th November 2018 (*"the Assignment Agreement"*) with an Effective Date of December 1, 2018, and now confirm and incorporate by reference herein the said Assignment Agreement;

WHEREAS, pursuant to the Assignment Agreement, Assignor desired to assign and transfer to Assignee all of its right, title, and interest in and to the patent applications and patents granted thereon listed in Annex 1 including any divisional application filed in relation thereto, and Assignee desired to acquire the same;

NOW THEREFORE, for valuable consideration the receipt, adequacy and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Assignors hereby sells, assigns, transfers, and conveys to Assignee its entire right, title and interest in and to the patents and patent applications listed in Annex 1, including its entire right, title and interest, in all countries of the world, in and to all inventions disclosed in the said patents and patent applications; its entire right title and interest in and to all continuations, continuations-in-part (but only to the extent the claims thereof are entitled to the benefit of the parent priority date), divisions, reissues, reexaminations, extensions or available foreign equivalents thereof (to the extent that a deadline for a filing has not passed without such filing having being made), and including the right to claim priority from said patents and patent applications under the Paris Convention for the Protection of Industrial Property, and under any and all other such treaties and agreements to which Italy are a party and which afford similar priority-claiming privileges, in all countries of the world, all Letters Patent or extension certificates which may be granted thereon for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignors if this Assignment and sale had not been made; together with all income, royalties, damages or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the patents and patent applications, with the right

to sue for, and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives.

2. Assignors hereby covenant and agree that Assignors shall execute, or cause to have executed any confirmatory assignment of the patents and patent applications listed in Annex 1 (hereinafter, the "Patents") that may be reasonably required in addition to the signing of this Assignment and reasonably requested by the Assignee, its successors, assigns or other legal representatives, in order to transfer the ownership of the Patents in individual countries and to effectuate the purposes of this Assignment it being understood that any expense incident to the execution of such papers shall be borne by the Assignee, its successors and assigns.
3. Assignors hereby request the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable foreign jurisdiction:
 - 3.1 to record Assignee as the assignee and owner of the Patents; and
 - 3.2 to issue patents on applications as described above, to issue all letters patent for these inventions to Assignee, its successors and assigns, in accordance with the terms of this Assignment.
4. This Assignment may be executed in counterparts, each of which, when executed, shall be deemed an original, and all of which shall constitute one and the same agreement and shall become effective when one or more counterparts have been signed by each of the parties and delivered to the other party, it being understood that both parties need not sign the same counterpart.
5. No variation of this Assignment shall be effective unless it is in writing and signed by the parties (or their authorized representatives).
6. This Assignment and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with Italian Law.
7. The parties irrevocably agree that the Court of Rome shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this assignment or its subject matter or formation (including non-contractual disputes or claims).

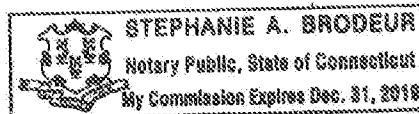
