 - (f) all extensions, renewals, reissues, divisions, and continuations (or their legal equivalents) of any applications or Letters Patent referred to above.
- 2) I authorize and request the Commissioner for Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States whose duty it is to issue patents or similar legal protection on applications to issue to Assignee all Letters Patent or similar legal protection for the Invention or improvements.
- 3) I agree that, upon the request of the Assignee, I will
 - (a) execute any all divisional and renewal applications for the Inventions or improvements;
 - (b) execute any supplemental oath relating to the Inventions or improvements;
 - (c) execute any application for reissue or extension of any Letters Patent that may be granted upon the Inventions;

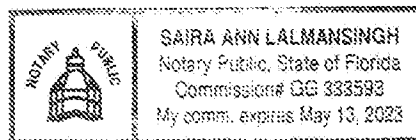
