**TERMINATION AND RELEASE OF
SECURITY INTEREST IN PATENTS**

This Termination and Release of Security Interest in Patents (“Patent Release”) is made as of August 1, 2019, by **JEFFERIES FINANCE LLC**, a Delaware limited liability company (in such capacity, together with its successors and assigns in such capacity, “Administrative Agent”) in favor of **LOPAREX LLC**, a Delaware limited liability company with an address at 1255 Crescent Green, Suite 400, Cary, North Carolina 27518 (the “Grantor”).

WHEREAS, Grantor granted Administrative Agent, under the terms of the Patent Security Agreement, a security interest in favor of Administrative Agent, in, to and under all of its Patent Collateral, including without limitation the Patents listed in Schedule A.

WHEREAS, Administrative Agent has agreed to terminate and release its security interest in all such Patent Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, for itself and on behalf of the Secured Parties, hereby terminates the Patent Security Agreement and releases, terminates and discharges any and all of its security interest in and lien upon the Patent Collateral (including without limitation the patents listed in Schedule A), and assigns, transfers and conveys to Grantor any and all right, title or interest in, or to, the Patent Collateral that the Administrative Agent may hold.
