AND for the same consideration, Assignor hereby covenants and agrees to and with Assignee, its successors, legal representatives and assigns, that Assignor will sign all papers and documents, take all lawful oaths and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of the Patent and any Letters Patent and applications for Letters Patent for said inventions and/or applications that depend from said Patent, without charge to Assignee, its successors, legal representatives and assigns, whenever counsel of Assignee, or counsel of its successors, legal representatives and assigns, shall advise is lawful and desirable: in any proceeding in connection with said inventions, Patent, or said applications for Letters Patent, or in any proceeding in connection with said Patent, any Letters Patent or applications for Letters Patent for said inventions in any country, including but not limited to interference proceedings; or, in respect of any division, continuation or continuation-in-part of any application for Letters Patent that depends from said Patent; or in respect of any reissue, reexamination, inter partes or post grant review, or extension of the Patent, or of any Letters Patent to be obtained thereon.
