ASSIGNMENT

This Assignment Agreement ("Agreement") is made on July 10, 2019 (the "Effective Date"), by and between Dr. Fumio NEGORO of Kanagawa, Japan, ("Assignor") and Takashi INOUE of Tokyo, Japan, Yasuharu ISHIKAWA of Okayama, Japan, Yoshitsugu KOMIYA of Kanagawa, Japan and LYEE Corporation of Kanagawa, Japan ("Assignees").

RECITALS

WHEREAS, Dr. Fumio NEGORO, (Assignor) has made, conceived and invented certain new and useful subject matter as set forth in an application for United States Letters Patent, entitled:

DEFINITION STRUCTURE OF PROGRAM FOR AUTONOMOUSLY DISABLING INVADING VIRUS, PROGRAM EQUIPPED WITH STRUCTURE, STORAGE MEDIUM INSTALLED WITH PROGRAM, AND METHOD/DEVICE FOR AUTONOMOUSLY SOLVING VIRUS PROBLEM,

for which a non-provisional application for United States Letters Patent was filed on February 2, 2017, and identified by United States Serial No. 15/423,481 and issued as U.S. Patent 10,235,522 on March 19, 2019 ("522 Patent");

AND WHEREAS, Takashi INOUE, Yasuharu ISHIKAWA, Yoshitsugu KOMIYA and LYEE Corporation (Assignees), are desirous of acquiring a percentage interest in and to said U.S. Patent 10,235,522 only as contemplated below;

NOW, THEREFORE, for good and valuable consideration, the receipt for and sufficiency of which is hereby acknowledged by said Assignor and Assignees:

1. ASSIGNMENT. Assignor hereby transfers over unto Assignees, and Assignees accept, the following percentage interests in and to U.S. Patent 10,235,522:

10% to Mr. Takashi INOUE;
10% to Mr. Yasuharu ISHIKAWA;
20% to Mr. Yoshitsugu KOMIYA; and
60% to LYEE Corporation.

Such transfer of percentage interests shall include all royalties, fees, income, payments and other proceeds according to the above listed percentages.

2. ASSIGNOR'S REPRESENTATIONS AND WARRANTIES. Assignor provides no representations or warranties. Assignees hereby acknowledge that any finding or ruling subsequent to the date of this Agreement that the Patent is invalid or unenforceable shall not give rise to a cause of action against Assignor under this Agreement

3. BINDING. This Agreement shall bind, and inure to the benefit of Assignor and its legal representatives, successors and assigns. This Agreement shall not be binding upon the parties until it has been signed by or on behalf of each party.

4. COUNTERPARTS. This Agreement may be executed in several counterparts, each of which shall constitute an original and all of which, when taken together, shall constitute one agreement.


5. AMENDMENTS. No amendment or modification hereof shall be valid or binding upon the parties unless made in writing and signed as aforesaid.

6. ENTIRE AGREEMENT. This Agreement constitutes the entire agreement between Assignor and Assignees, and supersedes any prior understanding or representation of any kind preceding the date of this Agreement. There are no other promises, conditions, understandings or other agreements, whether oral or written, relating to the subject matter of this Agreement.






