PATENT ASSIGNMENT

a. All Letters Patent and registrations that may be granted or issued for the Patents; and all divisions, continuations, and continuations-in-part claiming priority back to the Patents;

b. All rights, priorities and privileges of Assignor provided under the laws of the United States, or any multinational law, compact, treaty, protocol, convention or organization, with respect to the foregoing rights;

c. All rights to sue at law or in equity for any infringement, impairment or other unauthorized use or conduct in derogation of the foregoing rights occurring prior to the Effective Date, including the right to receive all proceeds and damages therefrom; and

d. Any and all rights to obtain renewals, reissues, re-examinations, divisions, extensions or other legal protections pertaining to the foregoing rights (the rights in sections a-d, collectively the "Assigned Rights").

2. Assignee, its successors and assigns, shall hold the rights to the Assigned Rights for and during the existence of the term and life of such Assigned Rights, as fully and as entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.

3. This Assignment is effective as of the Effective Date.




