

**CERTIFICATE OF AMENDMENT OF  
FOURTH AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF  
VASCULAR IMAGING CORPORATION**

Vascular Imaging Corporation, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, hereby certifies as follows:

1. That the corporation's original Certificate of Incorporation was filed with the office of the Delaware Secretary of State on May 29, 2001, as Vascular Technologies, Inc.

2. That, pursuant to a written consent in lieu of a meeting pursuant to Section 141(f) of the General Corporation Law of the State of Delaware, the corporation's Board of Directors duly adopted the following resolution to amend the corporation's Fourth Amended and Restated Certificate of Incorporation filed on March 28, 2019:

RESOLVED: that the corporation's Fourth Amended and Restated Certificate of Incorporation is hereby amended by deleting Article FIRST in its entirety and replacing it with the following:

FIRST. The name of the corporation (the "**Corporation**") is: Phyzhon Health Inc.

3. That, pursuant to Section 242(b)(1) of the General Corporation Law of the State of Delaware, no vote or written consent of stockholders is required to effectuate the amendment set forth above.

4. That this Certificate of Amendment shall be effective upon filing.
