ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby acknowledges that ASSIGNOR has sold, assigned, transferred, set over, conveyed, and delivered, and by these presents will and does hereby sell, assign, transfer, set over, convey, and deliver unto said ASSIGNEE, its successors, legal representatives, and assigns, the entire right, title, and interest throughout the world in, to, and under the Application and the Work, including all provisional applications relating thereto, and all nonprovisional applications claiming priority thereto, including, all divisions, continuations, continuations-in-part, continued prosecution, reissues, and reexaminations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all rights of priority under International Conventions and any related Letters Patent which may hereafter be granted or filed in any country or countries foreign to the United States, all extensions, renewals and reissues thereof; and ASSIGNOR hereby authorizes and requests the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all related Letters Patent to the ASSIGNEE, its successors, legal representatives, and assigns, in accordance with the terms of this instrument.

AND ASSIGNOR WILL AND DOES HEREBY sell, assign, transfer, set over, convey, and deliver to ASSIGNEE, its successors, legal representatives, and assigns, the right to all income, royalties, fees, and payments now or hereafter due or payable in respect to the rights assigned hereby; the right to enforce any rights assigned hereby and to file any causes of action, in law and/or equity, relating to rights assigned hereby; and all claims for damages and all remedies arising out of any violation of the rights assigned hereby that may have accrued prior to the date of assignment to ASSIGNEE, or may accrue hereafter, including, but not limited to, the right to sue for, collect, and retain damages for past infringements of said Letters Patent before or after issuance.

AND ASSIGNOR WILL AND DOES HEREBY covenant and agree that ASSIGNEE, its successors, legal representatives, and assigns, shall hold and enjoy any rights assigned hereby as fully and exclusively as such rights would have been held and enjoyed by ASSIGNOR had this assignment not been made.

AND ASSIGNOR WILL AND DOES HEREBY covenant and agree that ASSIGNOR has not made any agreement in conflict with this Assignment, and the rights assigned hereby are free from all prior assignment, grant, mortgage, license, or other encumbrance.

AND ASSIGNOR WILL AND DOES HEREBY covenant and agree that ASSIGNOR will communicate to said ASSIGNEE, its successors, legal representatives, and assigns, any facts known to ASSIGNOR respecting the Application or the Work, and testify in any legal proceeding, assist in the preparation of any other provisional or non-provisional applications relating to the Application and the Work or any improvements made thereto, sign all lawful papers, authorize the filing of and execute and make all rightful oaths and/or declarations in connection with the Application and the Work including any improvements made thereto, any patent applications filed therefrom, and any continuing application filed from any of the aforementioned applications, and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives, and assigns, to obtain and enforce proper patent protection for the Work in all countries.


