And the Seller hereby authorizes and requests the governing body of the pertinent country or region to issue any and all Letters Patent of the pertinent country or region on such inventions or resulting from the Patent Property or any continuations-in-part, continuations, divisions, substitutes, reissues, extensions or registrations thereof to the Buyer, as assignee of the Seller's interest.

And the Seller hereby covenants that the Seller is the sole and exclusive owner of the Patent Property and has full right to convey the interests herein assigned, and that he has not executed and will not execute, any agreement in conflict herewith.

And the Seller hereby agrees that the covenants and conditions contained in this Patent Assignment shall apply to and bind the Seller and its heirs, legal representatives, successors and permitted assigns.

The Seller agrees that upon request by the Buyer, or its successors, assigns or other legal representatives that the Seller or his successors, assigns or other legal representatives shall do all other legal acts reasonably necessary for the perfecting, securing and completing of this assignment at the Buyer's expense and request, as well as provide such other material, information, or assistance as Buyer or its successors, assigns or other legal representatives may consider necessary.
