ASSIGNMENT




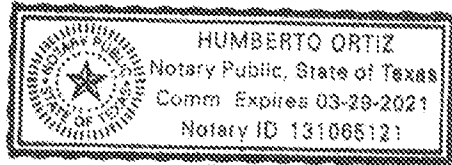
