ASSIGNMENT

The Assignors hereby covenant and agree, for both the Assignors and the Assignors' legal representatives, that Assignors have the full right to convey the interest assigned by this Assignment; and that the Assignors will assist the Assignees in the prosecution of the patent application identified above, in the making and prosecution of any other applications that the Assignees may elect to make covering the invention identified above, in vesting in the Assignees like exclusive title in and to all such other patent applications and patents, in the prosecution of any interference which may arise involving said invention, or any such patent application or patent, and in assisting Assignees in enforcement of any rights arising out of this Assignment; and that the Assignors will execute and deliver to the Assignees any and all additional papers which may be requested by the Assignees to carry out the terms of this Agreement.

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignees in accordance with the terms of this Assignment.
