WHEREAS, Assignee agrees to assume such rights, obligations, interests and liabilities of Assignor under the Assignment Document as it relates to the Patents being assigned herein.

NOW THEREFORE, in consideration of the foregoing, the parties agree as follows:

1. Assignor hereby does transfer and assign unto Assignee all of Assignor's rights, obligations, interests and liabilities under the Assignment Document along with such rights, obligations, interests and liabilities relating to the Patents including, without limitation, the entire right, title, and interest in and to the Patents being assigned herein, including all rights to sue for past, present and future infringement of the Patents being assigned herein, including the right to collect and receive any damages, royalties, or settlements for such infringements, and any and all causes of action relating to any of the inventions or discoveries described in the Patents being assigned herein.
2. For and in consideration of the assignment hereunder, Assignee hereby assumes all of Assignor's rights, obligations, interests and liabilities under the Assignment Document as it relates to the Patents being assigned herein to the same extent as though it had originally been named as a party thereto and agrees to observe, perform and fulfill all the terms and conditions of the Assignment Document as it relates to the Patents being assigned herein, including without limitation the payment obligations, to the same extent as if it had been originally named as a party thereto.
3. This Agreement shall be binding upon and inure to the benefit of the parties and their respective successors and assigns.




