AND for the same consideration, Assignor hereby covenants and agrees to and with Assignee, its successors, legal representatives and assigns, that Assignor will sign all papers and documents, take all lawful oaths and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of said Letters Patents, whenever counsel of Assignee, or counsel of its successors, legal representatives and assigns, shall advise: that any proceeding in connection with said inventions, or any proceeding in connection with any of said Letters Patents in any country, including but not limited to interference proceedings, is lawful and desirable; that any reissue, reexamination or extension of any of said Letters Patent, to be obtained thereon, is lawful and desirable.

AND Assignor hereby requests the Commissioner of Patent and Trademarks to issue said Letters Patents of the United States to Assignee, as Assignee of said Letters Patents to be issued thereon, for the sole use and benefit of Assignee, its successors, legal representatives and assigns.


