AppNexus Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the Delaware General Corporation Law (the "DGCL")

DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of the Corporation, by written consent, pursuant to Section 141 of the DGCL adopted a resolution proposing and declaring advisable the following amendment (the "Amendment") to the Eleventh Amended and Restated Certificate of Incorporation of the Corporation (the "Certificate of Incorporation");

RESOLVED, that the Certificate of Incorporation of the Corporation be amended by changing the Article First therefor so that, as amended, the Article First shall be and read as follows:

FIRST. The name of the Corporation is Xandr Inc.

SECOND: That the Amendment was duly adopted in accordance with the applicable provisions of Sections 141 and 242 of the DGCL.

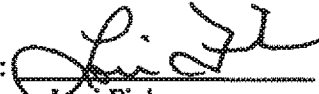
THIRD: Pursuant to Section 242(b)(1) DGCL, stockholder approval is not required.
