term or terms for which the same may be granted, including all priority rights under the Paris Convention for the Protection of Industrial Property;

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks and any officials of foreign countries whose duty is to issue patents or any legal equivalent thereof to issue same to Assignee, its successors and assigns, in accordance with this Assignment;

Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment; and

Assignor further covenants that said Assignee will, upon its request, be provided promptly with all pertinent facts and documents relating to the Intellectual Property, said applications, said Letters Patent and said legal equivalents as may be known and accessible to Assignor and that Assignor, its employees, representatives, and/or assigns will testify as to the same in any interference, re-examination, or litigation related thereto and will promptly execute and deliver to Assignee or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue, reissue, continue and enforce the Intellectual Property, said applications and said Letters Patent and said equivalents in the United States or in any other country, which may be necessary or desirable to carry out the purposes thereof.
