TO THE
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION**

OF

The Stroke Project, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify that:

1. The name of the Corporation is The Stroke Project, Inc. The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on October 6, 2015. An Amended and Restated Certificate of Incorporation was filed with the Secretary of State on June 22, 2017 (the "Certificate of Incorporation").

2. The Board of Directors of the Corporation duly adopted a resolution, pursuant to Section 242 of the General Corporation Law of the State of Delaware, setting forth this Certificate of Amendment to the Amended and Restated Certificate of Incorporation of the Corporation (the "Certificate of Amendment"), declaring said Certificate of Amendment to be advisable and in the best interests of the Corporation, and approving said Certificate of Amendment.

3. Article I of the Amended and Restated Certificate of Incorporation is hereby amended and restated in its entirety to read as follows:

ARTICLE I


"The name of this corporation is Imperative Care, Inc. (the "Corporation")."
