Pursuant to Title 8, Section 251(c), of the Delaware General Corporation Law, the undersigned corporation does hereby certify as follows:

FIRST: The name and state of incorporation of the constituent corporations are: ABBYY Process Intelligence Inc., a Delaware corporation ("Merger Sub") and TimelinePI, Inc., a Delaware corporation ("TimelinePI", and together with Merger Sub, the "Constituent Corporations").

SECOND: The Agreement and Plan of Merger, dated as of July 5, 2019 (the "Merger Agreement"), by and among TimelinePI, ABBYY Plc., a Cyprus public limited company, ABBYY TPI Inc., a Delaware corporation, Merger Sub, and Scott Opitz, as the Stakeholder Representative, has been approved, adopted, certified, executed and acknowledged by each of the Constituent Corporations in accordance with the requirements of Title 8, Section 251 of the Delaware General Corporation Law.

SIXTH: The Merger Agreement is on file at 900 W Sproul Road #104, Springfield, PA 19064, the place of business of the Surviving Corporation.

SEVENTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation on request, without cost, to any stockholder of the Constituent Corporations.
