## Termination of Licence Agreement and transfer of patent rights

We refer to meetings, conversations and correspondence regarding the Licence Agreement between Sinvent AS (Sinvent) and Nor-X Industry AS (Nor-X) dated 2006-10-03.

The parties agree to terminate the Licence Agreement. As a result of the termination, the parties have further agreed that ownership of Patents N3 and N4 as described in Appendices 1-3 of Licence Agreement should be transferred from Nor-X to Sinvent:

‘Polymer compositions containing branched hybrid polymers and/or fat-soluble metal compounds as stabilizers’

Ownership of the remaining patents remains as described in the appendices.

Upon completion of such transfer, the Licence Agreement and all payment obligations arising from it will terminate. We ask Nor-X should immediately to take the necessary steps as regards the Norwegian Patent Office to transfer Patents N3 and N4 to Sinvent and to complete these steps as soon as possible.

Sinvent hereby provides its consent to the transfer. As documentation of the parties’ agreement, we request that the chairman of the board of Nor-X give his consent to termination and transfer by signing a copy of this letter and returning it as soon as possible to Sinvent.

## Avslutning av lisensavtale og overføring av patentrettigheter
