- (ii) The right to sue for damages and other remedies in respect of any infringement of such rights
- (iii) The right to claim priority under any national, regional or international law or treaty from any application for intellectual property rights in respect of the Inventions

AND NOW THEREFORE in consideration of the sum of 10 Norwegian Krone now paid by the Assignee to the Company, receipt of which is hereby acknowledged, the Company HEREBY ASSIGNS to the Assignee all right title and interest in and to the Inventions and in and to the Applications in any country of the world including:

- (i) The right to file applications for, and be granted, patents, utility models or other intellectual property rights in any country of the world (and including supplementary protection certificates, divisions, continuations, continuations in part, national or regional phases, reissues and extensions) in respect of the Inventions, whether under national regional or international arrangements
- (ii) The right to sue for damages and other remedies in respect of any infringement of such rights
