BACKGROUND

- A. Trent and Scott are the inventors of certain apparatus for use in unpacking shipping containers (the **Invention**). Two Australian provisional patent applications relating to the Invention were filed, namely Australian Patent Application No. 2017904246 and Australian Patent Application No. 2018901003 (the **Provisional Applications**). The Provisional Applications were filed in the name of Young Guns. Trent and Scott were and are the directors of Young Guns, and both of the Provisional Applications were filed by (and in the name of) Young Guns with the knowledge and consent of Trent and Scott.
- B. The Provisional Applications were subsequently assigned (from Young Guns) to YGCC.
- C. Non-provisional patent applications were subsequently filed in Australia, New Zealand, Canada and the USA. These non-provisional patent applications were filed in the name of YGCC, and they all claimed priority from both of the Provisional Applications (which by then also stood in the name of YGCC).

OPERATIVE PROVISIONS

1. DECLARATIONS BY INVENTORS

Each of Trent and Scott in their personal capacities and as inventors of the Invention confirms that they consented to the filing of the Provisional Applications by Young Guns, and each of them confirms that all of their rights relating to the Invention have been assigned, or (to the extent not provided for in any earlier agreement) all of their rights relating to the Invention are hereby assigned, to Young Guns, and they understand that all rights

relating to the Invention have been (or are hereby) further assigned by Young Guns to YGCC.

2. DECLARATION BY YOUNG GUNS

Young Guns confirms that it received and accepted the assignment of all rights to the Invention from the inventors, Scott and Trent, and further confirms that all rights relating to the Invention have since been assigned to YGCC, or (to the extent not provided for in any earlier agreement) that all rights relating to the Invention are hereby assigned to YGCC.

3. DECLARATION BY YGCC

YGCC confirms that it has received and accepted the assignment of all rights to the Invention from Young Guns, and accordingly is the holder of all rights in relation to the Invention.

4. MISCELLANEOUS

4.1 Severability

If anything in this document is unenforceable, illegal or void then it is severed and the rest of this document remains in force.

4.2 Governing Law

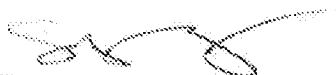
